INFORMATION ACT – 2005**

I.INTRODUCTION:-

In order to promote transparency and accountability in the working of every Public Authority and to empower the citizens to secure access to information under the control of each public authority, the Government of India have enacted "The Right to Information Act 2005", (RTI ACT) which came into force on 15.06.2005. In accordance with the provisions of section 4(1) (b) of this Act, the Metropolitan Transport Corporation (Chennai) Limited has brought out this Manual for information and guidance of the general public.

The purpose of this manual is to inform the general public about this department's organizational set up, functions and duties of its officers and employees, records and documents available with the department.

A person requiring any information under the Act may contact Thiru.S.Balasubramanian, Assistant Manager (Audit) Metropolitan Transport Corporation (Chennai) Limited, Chennai – 600 002, who has been designated as Public Information Officer. His office telephone No. is 2345-5801-Extn.238.

The Procedure and Fee structure for getting information are as under:-

- a) A request for obtaining information shall be made in writing or through electronic means either in person or by post to the Public Information Officer and must be accompanied by an application fee of Rs.10/- by cash or by means of Demand Draft or banker' cheque or court fee stamp/Treasure challan.

For providing information the request shall be made as at (a) above and the fee as below should be paid by Cash or Demand Draft.

- I. Rs.2/-for each page (in A4 or A3 size paper) created or copied.
- II. Actual charge or cost price of a copy in larger size paper.
- III. Actual cost or price for samples or models.
- IV. For inspection of records, no fee for the first one hour and a fee of Rs.5/- for each 15 minutes (or fraction thereof) thereafter.
- V. For Information provided in Diskette or floppy at the rate of Rs.50/- per Diskette or Floppy.
- VI. For information provided in printed form at the price fixed for each Publication.
- VII. Persons below the poverty line are exempt from the payment of fee for seeking information under the Right to information Act, 2005. The list of persons below poverty line approved by the Gram Panchayat and local bodies will be the basis for claiming this concession. An extract of the list, duly certified, will be sufficient to avail this concession.

The Public Information Officer shall credit / remit the amount as prescribed by the Accounts Department.

II. PARTICULARS OF ORGANIZATION,FUNCTION AND DUTIES:-

BRIEF HISTORY:-


The erstwhile Pallavan Transport Corporation Limited was formed in 1972 by taking over the business of Bus operation from the Government. In 1994 Pallavan Transport Corporation Limited, was bifurcated as Pallavan Transport Corporation Ltd., and Dr.Ambedkar Transport Corporation Limited. In 1997 it was renamed as Metropolitan Transport Corporation-I Limited, and Metropolitan Transport Corporation - II Limited respectively. Again in 2001, the Metropolitan Transport Corporation - II Limited was merged with the Metropolitan Transport Corporation - I Limited, and the Resultant Corporation renamed as Metropolitan Transport Corporation (Chennai) Limited. At present MTC is providing transport facilities to the public of Chennai Metro.

OBJECTIVE/PURPOSE OF THE CORPORATION:-

The objective of the Corporation is to provide efficient, economical and co-ordinate transport facility to the public in the jurisdiction of Chennai and its adjacent area within the radius of 50 kms. Accordingly, MTC operating 3233 buses. The Corporation has been registered under Companies Act, wholly owned by the Government and all the shares are held by the Tamil Nadu and its nominees.

DEPARTMENTS

ADMINISTRATION DEPARTMENT:-

This wing is headed by one Senior Deputy Manager (Human resources Management). The Departments mentioned above are under his control. This department deals with the recruitment in respect of various categories, following the rule of reservation, establishment matters, implementation of the policy decisions, implementation of government orders, Service details, pay control etc. of the employees. Public relation activities, issue of free passes, Labour welfare matters.

OPERATION WING:-

This wing is headed by one General Manager (Operation), the departments mentioned above are under his control. This department deals with the operation of bus services, maintaining fare tables, Time schedule, curtailment / augmentation, deviation of services, attending to the grievances of the travelling public regarding operation of bus services as well as on the complaints against the crew's behaviour, operation of chartered trips, issue of Students Concession Ticket and Monthly Season Ticket, checking of buses, collection of penalty, accident investigation, operation of Night Services etc.

TECHNICAL WING:-

This wing is headed by one General Manager(Technical). The Technical department is under his control .The maintenance of buses in the 32 Depots of this Corporation, Running of Work Shops and other Technical Units are the main functions.

ACCOUNTS & AUDIT DEPARTMENT:-

This wing is headed by one Chief Financial Officer. The functions are entirely accounts activities of the Corporation. The other functions are the settlement of terminal benefits to the outgoing employees, preparation of Annual Accounts and Budget etc.

The Audit Wing is functioning of all type of Auditing and also co-ordinates with Internal Auditors (External agencies) and obtain periodical reports from them.

III. POWERS AND DUTIES OF OFFICERS AND EMPLOYEES

(UNDER SECTION 4(1)(B)(II) OF THE RTI ACT)

The Corporation is headed by the Managing Director. He is assisted by a Joint Managing Director, Chief Financial Officer, General Managers (Operation/ Technical/ North / South), Senior Deputy Manager (HRD), Company Secretary, Deputy Managers and Assistant Managers. The Officers and Employees exercise the Administrative and Financial powers as laid in the Delegation of Financial powers and the Purchase Policy. The power and duties of the Officers are indicated below;

MANAGING DIRECTOR:-

The Managing Director is the Chief Executive Officer of the Corporation. He functions under the Supervision, control and direction of the Board of Directors. He is responsible for the careful observance of the Business Rules and Government instructions in the transaction of the business. He exercises general supervision and control over the staff working under him including

General Manager, Senior Deputy Manager, Deputy Manager, Assistant Manager etc., and is responsible for monitoring that the members of the staff do the work allotted to them efficiently and expeditiously. Policy matters and all important matters are dealt with in consultation with Secretary, Transport Department who is the Chairman and Director of the Corporation.

GENERAL MANAGERS:-

The General Manager (Operation) is responsible for the Bus Operation and the General Manager (Technical) is responsible for the Technical related works. Also, the General Manager of each regions (North & South) are responsible for operation and maintenance of the Buses in their respective Regions. They exercise general supervision and control over the Officers and employees working in the Region. They ensure that employees discharge their respective functions efficiently and also maintain discipline.

SENIOR DEPUTY MANAGER (HRD)

The Senior Deputy Manager (HRD) looks after the Personnel and Legal wing of the Corporation.

CHIEF FINANCIAL OFFICER & COMPANY SECRETARY:-

The above Officers located at the Corporate Office of the Corporation are over all in charge of Finance and Accounting Functions, Secretarial including Trust Accounts and Pension Payment and Audit of the activities of the Organization.

DEPUTY MANAGER / ASSISTANT MANAGER:-

The Deputy Managers and Assistant Managers exercise control over the sections and in Branches placed in charge of both regard to despatch of business and in regard to discipline.

1. GENERAL INFORMATION ABOUT AREA OF OPERATION:-

Chennai Metropolitan Area(CMA) covers an Area of 5,904 Square KMs of which is 2280 Sq miles from the proper miles and 50K.M. radius of in and around Chennai and its adjacent area. Chennai Metropolitan Area had a population of 12 million in 2024 and it has increased by 2.3%.

The Metropolitan Transport Corporation with a fleet strength of 3376 vehicles is operating 3233 services in 669 routes from 32 depots spread all over the Chennai and its adjacent areas. The bus utilization is 267 Km per day, 19,084 employees are working in MTC. MTC has 80 Established terminus from where the buses are operated and it has 300 Wayside terminus for convenience of the travelling public. About 30.50 lakhs passengers travelled daily in MTC buses.

Different Types of Services

The MTC has a good network of routes unlike other states, connecting directly different parts of Chennai with other parts of Chennai. The maximum route length is 50Km. between Thiruvannamiyur and Mahabalipuram.

MTC Limited is operating bus services in different types with different rate of fare approved by the Government are as follows:-

- a) Ordinary Services - White Board with Black letters & Digital Board
- b) Express Services - Green Board with White letters & Digital Board
- c) Deluxe Services - Blue Board with White letters & Digital Board
- d) A/c Bus services - Digital Board

CONCESSION TICKET ISSUED BY THE MTC LIMITED:-

At Present MTC issuing Rs.1000/- Travel As You Please Ticket(TAYPT) Monthly, Monthly Season Ticket (MST) passes for passenger and 50% Student Concession Ticket(SCT) pass to Students through 30 counters in Chennai.

1. Student 50% Concession Tickets(SCT) are issued through the counter from 1 to 13 of every month including holidays.
2. TAYPT Rs.1000/- concession pass issued through the counter from 7th to 22 of every month including.
3. MST concession pass issued through the counter from 1st to 22nd of every month including holidays.

50% STUDENT CONCESSION TICKET (SCT)**PROCEDURE: -**

Issue of 50% Student concession application forms, Registration, and issue for the first month of every academic year is being done through the concerned educational institutions. For the remaining months concessional pass will be issued directly to the student at the M.T.C.'s sales counters. Students can travel all the type of buses except A/c buses.

MST Monthly Season Tickets(MST) :-

MST Monthly Season Tickets are being sold by collecting the as per the fare from are from the destination and origin and travel in ordinary and Express buses. If the passengers wish to travel in Deluxe buses, the passenger can pay additionally pay Rs.11/- per trip to the conductor. Using this pass passenger can travel all the buses except A/c buses.

Procedure:-

New commuters those who like to get the Monthly Season Ticket(MST) should get an Identity card by remitting Rs.15/- from the any of the above said counters, by submitting recent Photo and Id proof. And then using this ID card can get concessional passes from any of the MTC's bus pass issuing counters.

Travel As You Please Ticket (TAYPT)

Passengers can avail Travel As You Please Ticket(TAYPT) Rs.1000/- card using this card passengers can travel many times in a day in all the type of buses except A/c buses.

New commuters those who like to get the TAYPT should get an Identity card Rs.15/- from the any of the above said counters, by submitting recent Photo and Id proof. And then using this ID card can get concessional passes from any of the MTC's bus pass issuing counters.

Above concessional tickets are issued as per the conditions printed on the ticket.

ISSUE OF FREE BUS PASSES TO STUDENTS:-

- 1) MTC issue free bus passes to all School students studying from I to XII and Government ITI, Polytechnic, Government Arts & Science College, Government Music College, Community College, Government Kavin Arts College, Government College of Architecture and Sculpture Mamallpuram.
- 2) Students apply free pass through concerned School/Colleges only.
- 3) Using the free pass Student can travel from their resident to College only and to travel all the buses except A/c buses.

CHARTERED TRIPS/HIRING OF BUSES BY GOVERNMENT DEPARTMENTS & PRIVATE PARTIES AND FILM SHOOTINGS:-

CHARTERED TRIPS/ HIRING OF BUSES - CONDITIONS:-

1. Chartered trips and hire buses will be provided within Chennai Metropolitan's operational Area only
2. Chartered trips and hire charges shall be paid by D.D., Net Banking, UPI payment.
3. M.T.C. is not liable for compensation or loss if any arises due to non-operation of chartered trips due to unforeseen reasons. Chartered trip charges alone will be refunded in case of non-operation except GST charges & Reservation charges will not refund.

Chartered trips – buses provide for one trip also and its charges are according to the stage wise/distance, to follow the above conditions only.

BUSES ARE GIVEN FOR FILM SHOOTINGS:-

MTC will give buses for Film Shooting also. The charges are tabulated below:-

CONDITIONS:-

1. The requisition letter to hire the bus is to be sent to General Manager(Operation), MTC Ltd, Chennai-2 at least 3 working days before the date of hire along with the full payment.
2. Refundable caution deposit of the film shooting charges shall be collected. The shed-out and shed-in timings of bus at the Depot shall be taken as the period of hire.
3. Payment is to be made in advance through demand draft drawn in favour of the Managing Director, Metropolitan Transport Corporation Ltd, Chennai-2, or online or RTGS.
4. Caution deposit will be refunded after completion of the film shooting and after obtaining the details of the operation from the Branch Manager of the concerned Depot.
5. To get the refund of the Caution Deposit, the caution deposit repayment voucher is to be duly filled and submitted.
6. For cancelling Film shooting of bus it should be intimated 24 hours in advance, if the cancellation is not intimated before 24 hours the caution deposit and the reservation charges shall be forfeited.

7. The buses hired will have to be utilized within the operational area of the Metropolitan Transport Corporation only.
8. The party should pay the cost of damages if any occurs during the period of film shooting with or without the knowledge. Party should pay damages fee or the cost of damage should be detected from the Caution deposit amount.

Luggage Fare:-

1. Up to 5kg weighing luggage per passenger will be allowed on free of fare in MTC buses. However, luggage weighing even less than 5Kg but carried for commercial purpose will be charged 1 passenger fare to the destination.
2. For the luggages which are estimated of weight ranging from 5kg to 20 kg, Rs.10/- or one passenger fare for the destination whichever is higher will collected as luggage fare.
3. Similarly for the luggages which are estimated of weight more than 20 kg, Rs.20/- or Two passenger fares for the destination whichever is higher will collected as luggage fare.

4. Government banned commodities, smuggling goods, easily inflammable commodities etc. will not be allowed to carry.
5. Luggages which are larger in size, occupying more space in the bus and giving hindrance to the other passengers will not be permitted.
6. Luggages will not be allowed during peak hours when more passengers are travelling in MTC buses.
7. Wet luggages which are affecting the co-passengers will not be allowed.
8. Luggages without passengers will not be allowed separately.
9. For transporting News paper luggages and postal luggages, prior permission has to be obtained. Loading and unloading of those luggages will be allowed at designated bus stops only.
